

## ALLERGENS AND INGREDIENTS STATEMENT

The Active Pharmaceutical Ingredients (APIs) manufactured and sold by Fermion Oy are produced by chemical synthesis and **no ingredients have been added** to it. Examples of the ingredients and allergens of general concern have been listed below.

- Preservatives
- Colors/Dyes
- Carbohydrates, mannitol, sorbitol, lactose, maltodextrin
- Flavorings (like strawberry, cherry, natural grape etc.)
- Starch (corn, rice, potatoes, oats, wheat, spelt), gluten (wheat, rye, barley)
- Alcohols, glycols, glycerine
- Monosodium glutamate (MSG)
- Nut (like almond, peanut, coconut) and fruit
- Eggs, soya, milk, dairy products, casein, sesame seed, lupin or other flowers, celery, mustard, palm oil
- Hydroxyanthracene derivatives
- Seafood/Fish /Iodine
- Yeast, Aflatoxins
- Sulfites or sulfuric compounds, nitrites
- Animal or human material, cell culture material
- Dioxins, PCB or other toxic halogenated organic compounds as ingredients
- Latex, rubber, silicone and PVC, Phthalates (like DEHP, DINP, PET) and Bisphenol A (BPA)
- Penicillin and other antibiotics, non-penicillin beta-lactam antibiotics
- GMO materials
- Melamine, talc
- Ethylenediaminetetraacetic acid (EDTA)
- Pesticides
- Doping materials
- Nanoparticles, radionucleotides
- Conflict minerals
